## Fostering

relationships to create a greater sense of community between the university and the parents of its students

## Engaging

parents as resources in career programming, mentoring, and internship and job placement

### Enhancing

opportunities for academically talented students through direct engagement with them, their families and other key influencers

## Recommending

strategies for strengthening the undergraduate experience

## Providing

individual philanthropic support at leadership levels

# What is the Anteater Grant Initiative?

Through the Anteater Grant Initiative, Parent Executive Board members hear firsthand from undergraduate organizations that create programs and resources that impact the UCI student body and the greater campus community.

Each organization resides under six categories that represent the needs and interests of undergraduate students.

### These categories include:

- Academic Support
- Community Outreach
- Division of Undergraduate Education
- Leadership Initiatives
- Student Health and Wellness
- Student Support

#### Parent Executive Board Engagement

The Parent Executive Board is invited to participate in two retreatstyle meetings: once in the fall and again in the spring. Receptions, including dinners hosted by the Parent & Family Engagement team, take place on Friday and are followed by Saturday's official board meeting. All members receive a detailed, post-meeting summary to keep the entire board informed, especially those who could not attend.

#### **Anteater Grant Initiative Fund**

Each year, Parent Executive Board members make donations to the AGI fund. The recommended donation is \$5,000 annually, with the option to allocate \$1,500 of the donation toward the Chancellor's Club Fund for Excellence, which supports first-generation college students.

Undergraduate organizations are invited to apply for AGI support. During the spring retreat, qualifying applicants present their grant proposals to the full board. Board members collectively review and select which organizations they would like to award each year, making a direct impact on current student initiatives.

- Access to events where members can learn how to help their student navigate career services, set senior year priorities, and encourage their student's lifelong alumni relationship with UCI
- Impact the lives of undergraduate students at UCI through focused philanthropy efforts

#### What is the level of commitment to be involved?

The Parent Executive Board meets for retreats twice a year and is invited to receptions where it is highly encouraged to bring their students. Members are recommended to contribute \$5,000 annually for each year their student is an undergraduate. In addition, we ask members to consider a capstone gift in honor of their child's graduation that would support an area important to their student and/or family.

# Does UCI accept matching gifts from parents' places of employment?
